

Privacy polity

Our privacy policy aims to ensure guarantee that the information collected will not be provided, published or marketed in any circumstances. Your information is important. So we keep all data stored safely.

The ConeX Club respects its users and is committed to safeguarding your privacy. Therefore, it was necessary to develop this privacy policy that establishes policies regarding the collection, security, the use of personal information. By visiting, using and / or register on the site, the user expresses his consent to the following detailed practices. The policy comprises the privacy practices according to compliance with relevant Brazilian legislation.

Information We Collect

The information collected includes, among others, the following data: full name, social security number, full address, phone, e-mail, you must create a username and password and agree to the Policies and Procedures.

The data and information collected will be stored in a safe environment, observing the state of available technology, and can only be accessed by qualified and authorized by ConeXClub.

We use the information we collect on all of our services to provide, maintain, protect and improve those services.

The ConeX Club may record or monitor telephone calls made to our customer service department to carry out quality controls and training of our employees. The recordings will be kept for a reasonably necessary time and then deleted, always the sole discretion of ConeX Club.

When permitted by law, the ConeX Club may obtain personal information about the users and add it to the Personal Information provided either from affiliated entities, business partners or other independent external sources, such as public databases, information collected during a call telephone with the customer service department and / or through interactive applications. Consider that all the information collected about the user can be combined with your Personal Information in order to, for example, tailor our ads to their needs and develop new products and services that may be of interest.

Protection of passwords and login

By purchasing a benefit you must register in ConeXClub, we ask to create a username and password (that is, access to a private account within the Website). If you forget your account or password, you must ask again in the ConeXClub site, which we will send the data to your email.

Information Security

We do not disclose information we hold unauthorized.

Unless we have a legal or judicial decision, users information will never be transferred to third parties or used for purposes other than those for which it was collected.

Any information provided by users will be collected and stored according to the strictest standards of security and reliability.

Access to information collected is restricted to authorized employees who make the appropriate use of such data. Those who improperly use this information in violation of this Privacy Policy and Information Security will be subject to administrative and disciplinary measures, in addition to appropriate legal.

Use of Information

Make the collection of any product or service purchased through the site as well as the identification of the addressee;

Answer any queries and user requests;

Provide access to the restricted area of the site;

Preparing general statistics, to identify the users profile and development of connections Club campaigns;

Ensure the safety of users and customers;

Keep updated the records of users to phone for contact purposes, e-mail, SMS, direct mail or other media;

Inform about news, promotions and events ConeX Club and its partners.

Third-party access to Personal Information

The user give your their consent to the ConeX Club to share the Personal Information relevant to the management of stocks of products and services designed to benefit one club that you hire through our website. Also to share the Personal Information with service providers such as credit cards, business analysis, customer care service, marketing and fraud prevention. Also, when necessary, we can allow service providers to collect Personal Information on our behalf, or to facilitate the delivery of online advertising to your interests.

Cancellation policy resigns

When you sign on the ConeX Club Website, the user have the option of receive promotions campaigns, messages or email alerts about offers. The user may change their selection at any time by e-mail setup of the ConeX Club Website. ConeX Club reserves the right to restrict the registration of users who agree to receive promotional campaigns, messages or email alerts, even if not currently do. Anyway, in every e-mail sent have the option to stop receiving messages

General provisions

The ConeX Club may amend this Privacy Policy at any time with or without notice. However, if it is significantly altered, shall be informed to all USERS about the change by virtual notice.
